

- This yearly affiliation is accorded on the basis of the AICTE approval and subjects to the recommendation of inspection committee.

- Pay scales, allowances and CPF must be given to faculty as per AICTE norms. - 07. All other rules framed by the AICTE, New Delhi, Rajiv Gandhi Proudyogiki Vishwavidyalaya, and DTE from time-to-time should be strictly followed.
- 08. Faculty Members & Other Staff should be appointed on regular basis as per the norms laid down by the AICTE & must be paid as per the AICTE norms.
- O9. All laboratories / workshop are provided and fully established for various courses/discipline by providing space, furniture, equipment, experimental setups and licensed software as per AICTE norms. The library must be augmented with national and international journals.
- 10. The university reserves the right to visit the institution any time it may be fit to verify the compliance of norms and standards of AICTE/RGPV/DTE.
- 11. It's the responsibility of the institution to provide correct information regarding compliance.
