I am to state that on consideration of the report of the Expert Committee which assessed the proposal on 22.3.1993; the recommendations of the Standing Committee of the Western Regional Committee (MRC) at its Meeting held on 29.3.1993; the compliance report from the Management vide their letter dated 10.5.1993 and the recommendations of the Western Regional Committee held on 25.6.1993, the All India Council for Technical Education (AICTE) has accorded approval to the Hai-Hay Kshatriya Education Society, Bhopal to set up Laxminarayan College of Technology, Bhopal to conduct the following Degree Courses with the annual intake shown against each with effect from the year 1993-94:

The above approval is subject to fulfilment of the following conditions :

- 1. The land under possession of the Society admeasuring 25 acres and 34 decimal for the College shall be utilised solely for the permanent establishment of the College and that a certificate from the authorities concerned shall be submitted stating clearly that the current lease deed will be extended and that the College shall allowed to be set up on a permanent basis on this land.
- The Society shall arrange adequate funds for the construction of the buildings in order that the necessary
 infrastructural facilities as recommended by the WRC are made available from year to year basis for the
 running of the College.
- The Society shall appoint 13 (thirteen) faculty members already selected on receipt of this approval and further appointments shall be made as per AICTE norms.
- 4. The Society is permitted to utilise the temporary building inspected by the Expert Committee of the Western Regional Committee (WRC) for the years 1993-94 and 1994-95 after carrying out necessary alterations and thereafter the College shall shift to the permanent site.
- The College should conduct the courses only after obtaining the permission of the State Govt. and affiliation from the University of Bhopal.
- The Management including the Governing Body of the College shall be constituted and the Chairman of the Body
 appointed as per the guidelines of the AICTE.

- The Management shall provide infrastructural and instructional facilities to run the courses as per AICTE 7. norms and standards under guidelines from the Western Regional Committee.
- The teaching staff shall be recruited on an All India basis by open selection and as per procedure, qualifications, experience etc. as prescribed by the AICTE from time to time. State-based selection would be permissible for such posts for which the State Govt. prescribes "State-Based Selection" as a general policy.
- All admissions shall be made on merit and as per the guidelines issued by the AICTE from time to time.
- The tuition and other fees shall be within the overall criteria prescribed by the AICTE. No capitation fee will be charged from students/ guardians of the students in any form for admission.
- The AICTE scales of pay should be granted to the teaching faculty. 11.
- The accounts of the College shall be audited by a Chartered Accountant and shall be open for inspection by the 12. AICTE or anybody authorised by it.
- The College or the Management shall not alter the approved intakes under any circumstances without the prior 13. approval of the AICTE.
- The College or the Management shall neither close any of the approved courses nor start any new course in the College without the prior approval of the AICTE.
- The College and the Management shall follow strictly any further conditions as may be laid down by the AICTE from time to time.

The Management shall submit the necessary undertaking duly registered on the prescribed format within two weeks of receipt of this letter.

This approval is also subject to full compliance with the SCHEME as prescribed by the Supreme Court in its judgement dated 4.2.1993 in W.P.(C) No. 607 of 1992 with other NPs in the case of Unnikrishnan, J.P. and others etc. etc. vs. State of Andhra Pradesh and others etc. etc. and the related guidelines and criteria as may be issued by the AICTE, UGC or the Central Govt. from time to time as applicable to the College.

In the event of non-compliance by the College or the Management with regard to the above conditions and the quidelines & norms laid down by the AICTE from time to time, the AICTE or a body or a person authorised by it will be free to take measures for withdrawal of its approval or recognition, without consideration of any related issues and that all liabilities arising due to such withdrawal of approval would be that of the College and or the Management.

A Committee of the concerned Regional Committee will visit the College in June, 1994 to assess the progress made by the College and to make recommendations thereon for consideration of the Regional Committee and the AICTE.

I am to request you to take further necessary action to set up the College and to communicate the progress made in this behalf to the concerned Regional Committee under intimation to the AICTE.






