## **Admission Rule for 2025-26**

### B.Tech:

Passed 10+2 examination with

(For Civil/Mechanical)Physics, Mathematics & Chemistry

(For All other Courses) Physics, Mathematics & Computer Science/Electronics/Information Technology/ Biology/Informatics Practices/ Biotechnology/Technical Vocational subject/ Agriculture/ Engineering Graphics/ Business Studies/Entrepreneurship (Any One) . Obtained at least 45% marks (40% marks in case of candidates belonging to reserved category) in required three subjects.

**NOTE**: In JEE Only positive composite score candidates are eligible.

OR

Passed Diploma (in Engineering and Technology)examination with at least 45% masks (40% marks in case of candidates belonging to SC/ST/OBC (excluding creamy layer) category of Madhya Pradesh) Subject to vacancies in the First Year, in case the vacancies at lateral entry are exhausted.

#### B. Pharm.:

Candidate shall have passed 10+2 examination conducted by the respective State/Central Government authorities recognized as equivalent to 10+2 examination by the Association of Indian Universities (AIU) with **English** as one of the subjects and Physics, Chemistry, Mathematics (P.C.M.) and or Biology (P.C.B./P.C.M.B.) as optional subjects individually.

## D. Pharm.

A candidate pass in 10+2 examination (science academic stream) with Physics, Chemistry and Biology or Mathematics.

# **Lateral Entry (B.Pharmacy):**

Admission qualification for lateral entry to B.Pharm shall be a pass in Diploma Pharmacy course an institute approved by the PCI u/s 12 of Pharmacy Act. 1948.

# **Lateral Entry (B.Tech):**

i. Passed Minimum THREE years / TWO years (Lateral Entry) Diploma examination with at least 45% marks (40% marks in case of candidates belonging to reserved category) from an institute recognized by AICTE/UGC in ANY branch of Engineering and Technology.

OR

ii. Passed B.Sc. Degree from a recognized University as defined by UGC, with at least 45% marks (40% marks in case of candidates belonging to reserved category) and have passed 10+2 examination with Mathematics as a subject.

### MCA:

A candidate should be passed any graduation degree (e.g. B.E./B.Tech./BCA/B.Sc./B.Com/BA/B. Voc etc) with mathematics at 10+2 level or graduation level with at least 50% marks and 45% marks in case of SC, ST, OBC (excluding Creamy Layer) category of Madhya Pradesh. Recognized Bachelor's degree of minimum 3 years duration.

### **MBA**:

A candidate should be a Graduate with at least 50% marks and 45% marks in case of SC, ST, OBC category of Madhya Pradesh. The Bachelor's degree must be of minimum three years duration after passing Higher Secondary (10+2) examination of (10+2) system or equivalent.

### M.E./M.Tech.:

A candidate seeking admission to **M.E. / M.Tech.** courses should be a Graduate in relevant field of Engg/Technology with at least 50% marks. Candidate belonging to SC/ST/OBC (excluding creamy layer) categories of Madhya Pradesh with at least 45% marks. Bachelors degree should be of minimum of four years duration should have been obtained from any AICTE approved institution or Indian University or from a foreign University recognised by Association of Indian Universities (AIU)or institute recognized by the AIU or any Institutes of national importance (i.e.IITs/IISc/ NITs etc.), duly recognized by the MHRD, as equivalent thereto.

NOTE: Rounding of marks or percentage is not permissible.

#### M.Pharm.:

A candidate seeking admission to **M. Pharm.** courses should be a Graduate in Pharmacy (From an Indian university approved by PCI) with at least 55% marks. Candidate belonging to SC/ST categories of Madhya Pradesh with at least 50% marks.

NOTE: Rounding of marks or percentage is not permissible. DIPLOMA:

Passed 10+2 system 10<sup>th</sup> std/SSC or equivalent examination.

For Diploma (Mining & Mine Surveying) course :- Only male candidate and age should not be less than 16 year as on 01-01-2025 allowed.
